Application by Eggborough Power Limited for an Order granting development consent for the proposed Eggborough CCGT

Advice following issue of decision to accept the application for examination

On 27 June 2017 the Secretary of State decided to accept the above application for examination.

This letter comprises advice to the Applicant provided under section 51 of the Planning Act 2008 (PA2008). It should be read in conjunction with the Eggborough s55 Acceptance of Applications checklist (the Checklist) issued alongside it.

The Applicant should pay close attention to the content of this letter, and consider carefully how appropriate action might be taken in response to the advice issued within it.

Section 42(1)(a) persons prescribed

As the published Checklist sets out, it appears on the basis of the information provided by the Applicant that the below listed potentially relevant bodies were not consulted at the pre-application stage:

Unless there is a good reason in each case on the basis of which the Applicant is confident that these bodies are not relevant to the proposed development, the



Applicant is advised to include these bodies, or their appropriate successors, in its s56 notification exercise.

Section 42(1)(d) persons

- Please undertake a systematic audit of all lists of consultees and Affected
 Parties due to receive notice against the Applicant's up to date records of land
 rights and interests, the Book of Reference and the Land Plans.
- Please ensure that the names and addresses of all persons are accurately recorded.
- Please ensure that information from your latest diligence on land and rights is incorporated.

Minor discrepancies have been noted between the Book of Reference and the Consultation Report in relation to:

Carol Turner is listed as being consulted in Appendix 12.2 but with a different address from Carole Turner listed in the Book of Reference.

The Book of Reference lists D A Platt and David Arnold Platt at the same address. The Consultation Report lists David Platt & Sons as being consulted at s42 (Appendices 7.4 and 12.2) at the same address. In paragraph 12.15 of the Consultation Report (Doc Ref 5.1) David Arnold Platt (no address given) is listed as being consulted during the targeted stage 2a consultation but he is not included in Appendix 12.2.

The applicant is advised to check that the details are correct for these persons and ensure that they are correctly notified of the application in accordance with s.56(2)(d)

The applicant should ensure that the Book of Reference contains the information required by regulation 5 of the Infrastructure Planning (Applications Prescribed Forms and Procedure) Regulations 2009 and that these persons are correctly notified of the acceptance of the application in accordance with s.56(2)(d).

Part 2 of the Book of Reference

The Applicant has not identified any Category 3 persons in Part 2, however the Statement of Reasons (para 10.10) states that such persons have been consulted and certain individuals are identified in the Consultation Report as being Category 3 persons. The Applicant is therefore advised to take the following steps before providing notice of the acceptance of this application under PA2008 s56:



- Please undertake a systematic audit of prospective Category 3 persons, with reference to the latest diligence on land and rights, information included in the Consultation Report and in the Statement of Reasons
- If Category 3 persons not currently listed in the Book of Reference are identified then these will need to be included.

In light of the above, it is anticipated that an appointed Examining Authority will be likely to request for the Applicant to comprehensively review the Book of Reference, and to provide an updated version in the pre-examination period.
