The Eggborough Gas Fired Generating Station (Correction) Order 2018

The Eggborough Gas Fired Generating Station Order 2018 ("the Order")(a), which granted development consent within the meaning of the Planning Act 2008 ("the Act")(b), contains correctable errors within the meaning of the Act(c).
